## E. RANDOL SCHOENBERG

Mr. E. Randol Schoenberg is most recognized for his litigation on several prominent Nazi-looted art cases particularly *Republic of Austria v. Altmann*. He was a member of the lawyer's delegation to the official U.S.-Austria negotiations concerning Holocaust property restitution sponsored by the U.S. State Department representing over fifty families and all of the Austrian-Jewish Holocaust victims and heirs. He was also responsible for obtaining settlements for other Nazi-looted art including Picasso and Canaletto paintings.

E. Randol Schoenberg is a partner at the Los Angeles firm Burris & Schoenberg, LLP. His background boasts several years in civil and business litigation matters, arbitration and mediation. He has tried and argued before the California Court of Appeals, the Second and Ninth Circuit Court, the Los Angeles Superior Court and the U.S. Supreme Court.

Mr. Schoenberg is passionate about the arts and is an active member of the board of directors of two chamber and choral music societies. He is a graduate of Princeton University, where he earned a B.A. in Mathematics and a certificate in European Cultural Studies. In 1991, Mr. Schoenberg received his Juris Doctor degree from the University of Southern California. E. Randol Schoenberg lives in Los Angeles with his wife Pamela and their three children.

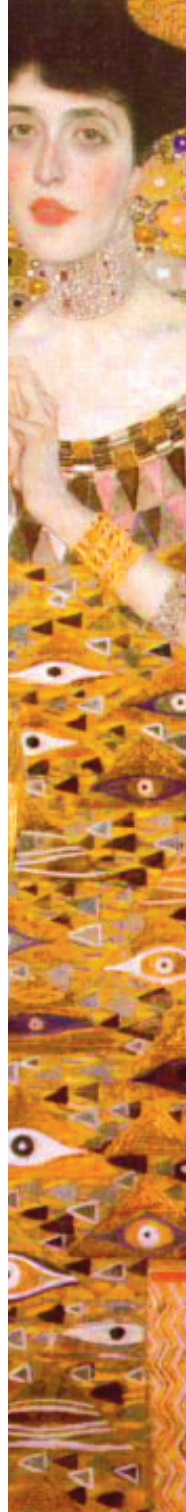
